UNFINISHED BUSINESS:



A RESOLUTION OF THE BOARD OF PUBLIC AFFAIRS OF THE VILLAGE OF SEVILLE, MEDINA COUNTY, OHIO CERTIFYING UNPAID UTILITY BILLS AT 83 WEST MAIN STREET TO THE MEDINA COUNTY AUDITOR FOR PLACEMENT ON THE PROPERTY TAX LIST AND DUPLICATE AS A LIEN FOR COLLECTION AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Revised Code and the Ordinances of the Village of Seville authorize the Board of Trustees of Public Affairs to manage, conduct and control the Village's water, sewer and electric utilities and to collect all rents and charges, and

WHEREAS, the Ohio Revised Code permits the Village of Seville to certify delinquent utility rents and charges to the Medina County Auditor for placement on the Property Tax List and Duplicate as a lien for collection, and

WHEREAS, the Board of Trustees of Public Affairs desires to certify delinquent utility rents and charges for utilities provided to the property currently owned by Jackie Donald and Irene Jones and known as 83 West Main Street PPN 012-21A-16-025 to the Medina County Auditor for placement on the Property Tax List and Duplicate as a lien for collection.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF PUBLIC AFFAIRS OF THE VILLAGE OF SEVILLE, MEDINA COUNTY, OHIO THAT:

The sum of \$1,261.02 is hereby certified as delinquent utility rents and charges for utilities provided to the property currently owned by Jackie Donald and Irene Jones and known as 83 West Main Street PPN 012-21A-16-025 to the Medina County Auditor for placement on the Property Tax List and Duplicate as a lien for collection
